NORTH KESTEVEN DISTRICT COUNCIL

WILSFORD CONSERVATION AREA ARTICLE 4 DIRECTION 2006

WHEREAS North Kesteven District Council (hereinafter called 'the Council') being the local planning authority for its area is satisfied that it is expedient that development of the descriptions set out in Schedule II hereto should not be carried out within the Wilsford Conservation Area which for identification purposes is delineated and edged with a heavy black line on the plan annexed hereto and comprising the dwellinghouses and their curtilages described in Schedule I hereto and indicated by grey shading on the said plan and to the extent set out in Schedule II hereto unless permission therefore is granted by the Council on an application made in that behalf.

NOW THEREFORE the Council in pursuance of the powers conferred upon it by Article 4(2) of the Town and Country Planning (General Permitted Development) Order 1995 **HEREBY DIRECTS** that the permission granted by those forms of development set out in Schedule II hereto shall not apply to the properties in the Wilsford Conservation Area and described in Schedule I to the extent permitted by Article 4(2) –(5) of the Town and Country Planning (General Permitted Development) Order 1995 and that this Direction may be cited as the 'North Kesteven District Council Wilsford Conservation Area Article 4 Direction 2006'.

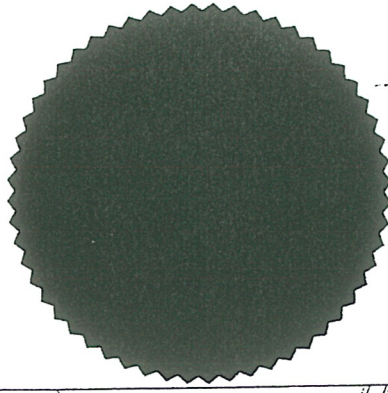

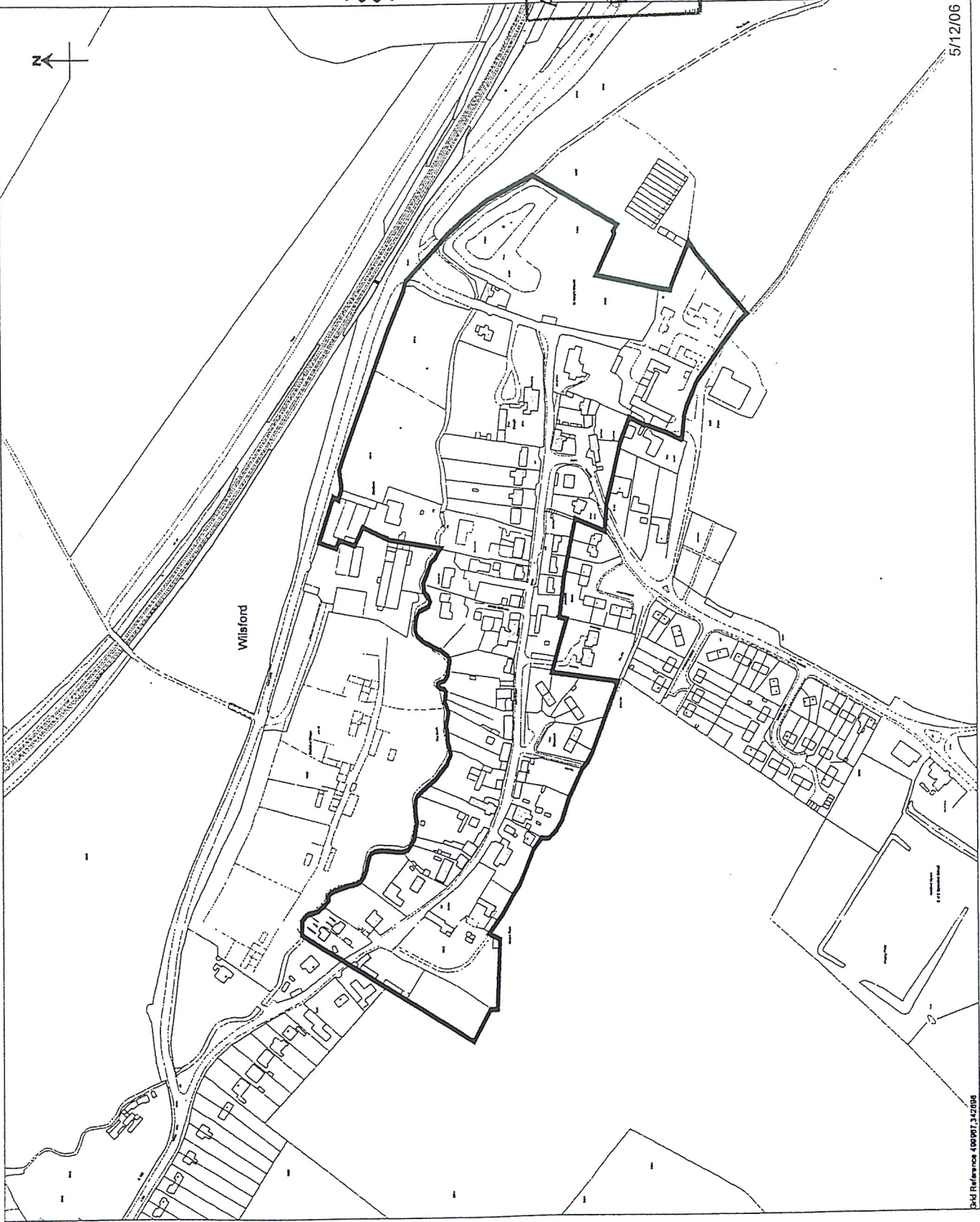
Buildings listed
