## Forthcoming Examination of the Central Lincolnshire Local Plan

I wrote to you on the 9<sup>th</sup> August 2022 to inform you that the Examination of the Central Lincolnshire Local Plan had commenced. I can now advise you that the hearing sessions forming part of the Examination will open on Tuesday 15<sup>th</sup> November 2022 at the Aspen Suite, Double Tree by Hilton Hotel, Brayford Wharf North, Lincoln LN1 1YW.

A copy of the of a statutory notice giving you details of the arrangements for the examination of the Local Plan, including the hearing sessions is attached to this letter for your reference.

The Inspectors have published the following documents concerning the examination, including the hearing sessions:

The Inspectors' MIQs identify the main issues of soundness and legal compliance upon which the examination will focus, including during the sessions; and the provisional Programme sets out the expected dates for the sessions. - **Tuesday 15<sup>th</sup> November 2022** – Date of the first hearing, for subsequent hearing dates, please refer to the Provisional Programme.

Please note that Week 4 of the Hearing sessions will be held virtually via Microsoft Teams and further information about these sessions will be circulated in due course.
