1. INTRODUCTION

- 1.1. The National Planning Policy Framework (NPPF) includes a requirement for local planning authorities to identify and update annually a supply of specific deliverable sites sufficient to provide five years' worth of housing against their housing requirements.
- 1.2. This report sets out the five year land supply position for Central Lincolnshire for the period 2022 to 2027. This report is based on monitoring data as at 31 March 2022 and as provided by each district within Central Lincolnshire.
- 1.3. This report sets out the details of:
 - the national and local policy context for calculating the five year supply;
 - the housing requirement for Central Lincolnshire during the five year period taking into account any necessary past undersupply and buffers as required by national policy;
 - the anticipated supply of homes across Central Lincolnshire in the five year period; and
 - the calculation of the five year housing land supply position for Central Lincolnshire.

2. POLICY CONTEXT

NATIONAL CONTEXT

- 2.1. The NPPF was originally published in 2012 and was subsequently revised in July 2018, February 2019 and July 2021. The revised NPPF included substantive amendments to the policy requirements in relation to housing land supply and it also introduced a number of other new policy requirements relating to plan-making and decision taking.
- 2.2. Paragraph 74 of the NPPF requires local planning authorities to identify and update annually a supply of "specific deliverable sites sufficient to provide a minimum of five years' worth of housing against their housing requirement set out in adopted strategic policies, or against their local housing need where the strategic policies are more than five years old."
- 2.3. The NPPF goes onto define what is to be considered 'deliverable' in its glossary:
 - "To be considered deliverable, sites for housing should be available now, offer a suitable location for development now, and be achievable with a realistic prospect that housing will be delivered on the site within five years. In particular:
 - a) sites which do not involve major development and have planning permission, and all sites with detailed planning permission, should be considered deliverable until permission expires, unless there is clear evidence that homes will not be delivered within five years (for example because they are no longer viable, there is no longer a demand for the type of units or sites have long term phasing plans).

- b) where a site has outline planning permission for major development, has been allocated in a development plan, has a grant of permission in principle, or is identified on a brownfield register, it should only be considered deliverable where there is clear evidence that housing completions will begin on site within five years."
- 2.4. Paragraph 74 also requires local planning authorities to "include a buffer (moved forward from later in the plan period) of:
 - a) 5% to ensure choice and competition in the market for land; or
 - b) 10% where the local planning authority wishes to demonstrate a five year supply of deliverable sites through an annual position statement or recently adopted plan, to account for any fluctuations in the market during that year; or
 - c) 20% where there has been significant under delivery of housing over the previous three years, to improve the prospect of achieving the planned supply."
- 2.5. The NPPF stipulates in footnote 41 that the 20% buffer in option c) is measured against the Housing Delivery Test, where this indicates that delivery was below 85% of the housing requirement.
- 2.6. The NPPF also allows for incorporation of a windfall allowance in the five year period in paragraph 71, where there is compelling evidence that they will provide a reliable source of supply. Any windfall allowance should be realistic having regard to the strategic housing land availability assessment, historic delivery rates and expected future trends.
- 2.7. Additional planning guidance is provided in the National Planning Practice Guidance (PPG), originally introduced in 2014. In July 2019 the Government updated much of its Guidance on 5 year housing land supply and Housing Delivery Test.
- 2.8. The PPG builds on the requirements of the NPPF providing substantial detail of what is expected of local planning authorities in order to demonstrate a five year supply of housing. This five year land supply report seeks to satisfy the requirements of both the new NPPF and the detailed guidance. Rather than duplicating the guidance here specific reference to national policy and guidance is drawn out in relevant sections detailing the Central Lincolnshire five year land supply position in this report.

THE LOCAL CONTEXT

- 2.9. The Central Lincolnshire Local Plan was adopted on 28 April 2017, covering the period 2012-2036. It is a joint plan covering the administrative areas of City of Lincoln, North Kesteven and West Lindsey.
- 2.10. The Local Plan introduced a housing requirement for Central Lincolnshire of 36,960 dwellings across the plan period which equates to 1,540 dwellings per year. This housing requirement is a Central Lincolnshire requirement and it has not been divided up into separate requirements for each of the local planning authorities in the area.
- 2.11. The Local Plan allocates more than 100 sites ranging from 25 dwellings in size to the sustainable urban extensions, the largest of which is anticipated to deliver approximately 6,000 homes and supporting infrastructure for the area. These sites are located in the top four tiers of the settlement hierarchy (Lincoln Urban Area, Main Towns, Market Towns and Large Villages) and only sites of 25 or larger were considered for allocation.

- 2.12. Sites coming forward lower down in the settlement hierarchy, specifically in 'Medium Villages' and 'Small Villages' do not have sites allocated. Instead through policies LP2 and LP4 a growth level was established for each village to understand the amount of development that could take place depending upon the size of the settlement and the services available. Sites delivered through these flexible policies make up an important part of the supply, and are accounted for as windfall, taking into account the permissions granted and homes built as detailed in this report.
- 2.13. Furthermore, a substantial part of the housing supply comes from small sites in urban areas. Local Plan Policy LP2 supports the principle of delivery of new homes in the top four tiers of the settlement hierarchy. However, as is detailed in this report, account has only been taken of small sites in the Lincoln Urban Area, meaning that no windfall assumptions have been made about small sites in the Main Towns, Market Towns or Large Villages.
- 2.14. The Local Plan is currently being reviewed and was submitted for examination in July 2022. Whilst the emerging Local Plan proposes a suite of new policies including new site allocations, a revised approach to growth in villages and more, this report does not take account of such changes at this time, but future updates will look to be adjusted to take account of the new Local Plan at the appropriate time when it progresses through examination.

3. THE FIVE YEAR REQUIREMENT

PROCESS

- 3.1. Paragraph 74 of the NPPF and 003 of the PPG¹ make it clear that for areas with a Local Plan that has been adopted within the last five years, the housing requirement set out in the strategic policies should be used for calculating the five year supply, but where a plan is more than 5 years old local housing need calculated using the standard method should be used in place of the housing requirement.
- 3.2. In April 2022 the Central Lincolnshire Local Plan was five years old and therefore the standard method for calculating local housing need is to be used for five year land supply calculations.
- 3.3. The approach to the standard method for calculating local housing need is set out in the PPG², providing a detailed step-by-step process to be followed. This process is as follows with the Central Lincolnshire calculations is set out in the tables after each step:

Step 1 – Setting the baseline

Set the baseline using national household growth projections (2014-based household projections in England, table 406 unitary authorities and districts in England) for the area of the local authority. Using these projections, calculate the projected average annual household growth over a 10 year period (this should be 10 consecutive years, with the current year being used as the starting point from which to calculate growth over that period).

In Central Lincolnshire the 2014 based projections for household increase between 2022 and 2032 for each district³ are as follows:

Note: Whilst this shows an average annual change of 923.8 dwellings across Central Lincolnshire, these totals are not grouped until the end of the process.

Step 2 – An adjustment to take account of affordability

Then adjust the average annual projected household growth figure (as calculated in step 1) based on the affordability of the area.

The most recent median workplace-based affordability ratios, published by the Office for National Statistics at a local authority level, should be used.

No adjustment is applied where the ratio is 4 or below. For each 1% the ratio is above 4, the average household growth baseline should be increased by a quarter of a percent. An authority with a ratio of 8 will have a 25% increase on its annual average household growth baseline.

Where an adjustment is to be made, the precise formula is as follows:

$$Adjustment\ factor = \left(\frac{Local\ affordability\ ratio\ -4}{4}\right)x\ 0.25 + 1$$

The most recent work placed affordability ratios were published in March 2022. The adjustment factor for Central Lincolnshire Districts are as follows:

Step 3 - Capping the level of any increase

A cap is then applied which limits the increases an individual local authority can face. How this is calculated depends on the current status of relevant strategic policies for housing.

Where these policies were adopted within the last 5 years (at the point of making the calculation), the local housing need figure is capped at 40% above the average annual housing requirement figure set out in the existing policies.

This also applies where the relevant strategic policies have been reviewed by the authority within the 5 year period and found to not require updating.

Where the relevant strategic policies for housing were adopted more than 5 years ago (at the point of making the calculation), the local housing need figure is capped at 40% above whichever is the higher of:

a. the projected household growth for the area over the 10 year period identified in step 1; or

b. the average annual housing requirement figure set out in the most recently adopted strategic policies (if a figure exists).

For areas covered by spatial development strategies, the relevant strategic policies are those contained within the spatial development strategy. Where a requirement figure for an authority in a spatial development strategy differs from that in a local plan, the figure in the spatial development strategy should be used as long as the spatial development strategy is no older than 5 years.

Where the relevant strategic policies within a spatial development strategy are over 5 years old, the relevant strategic policies at individual local authority level set out in the authority's local plan can be used in calculating the cap (if these policies are adopted after the relevant spatial development strategy, and the policies set out in the local plan are less than five years old, or older and has been found not to require updating as part of a plan review). If the relevant strategic housing requirement policies in the local authority's local plan are over 5 years old, then the local housing need figure is capped at 40% above whichever is the higher of:

a. the projected household growth for the area over the 10 year period identified in step 1; or b. the most recent number taken from the spatial development strategy.

As the projected household growth is not above the most recently adopted housing requirement in the 2017 Central Lincolnshire Local Plan and as the application of the adjustment factor does not push the requirement to 40% above the baseline projected household growth **Step 3 does not apply for Central Lincolnshire**.

Step 4 - cities and urban centres uplift

A 35% uplift is then applied for those urban local authorities in the top 20 cities and urban centres list.

Whether a cities and urban centres uplift applies depends on whether the local authority contains the largest proportion of population for one of the 20 cities or urban centres in England within the list.

The cities and urban centres list is devised by ranking the Office for National Statistics list of Major Towns and Cities by population size using the latest mid-year population estimates (nomis, official labour market statistics).

As at December 2020, this list of urban local authorities are: Birmingham, Bradford, Brighton and Hove, Bristol, Coventry, Derby, Kingston upon Hull, Leeds, Leicester, Liverpool, London, Manchester, Newcastle upon Tyne, Nottingham, Plymouth, Reading, Sheffield, Southampton, Stoke-on-Trent, and Wolverhampton.

As none of the above locations are within the area, **Step 4 does not apply for Central Lincolnshire.**

CALCULATION

If we combine Steps 1 and 2 of the process the following annual local housing need figures are derived from the standard method for Central Lincolnshire:

The baseline five year land supply requirement is therefore 5,511 (i.e. $5 \times 1,102$).

PAST COMPLETIONS AND SHORTFALL/SURPLUS

3.4. Previously it has been necessary to tally up the shortfalls or surplus against the Local Plan housing requirement, but as the Local Housing Need is now applied which includes the application of the affordability adjustment, past under-delivery is now taken into account within the setting of the Local Housing Need and does not need to be calculated further⁴.

3.5. However, for reference the annual delivery of dwellings since the start of the adopted Local Plan period in 2012 is provided in Table 4 below:

ADDING BUFFERS

- 3.6. In addition to the five year requirement, paragraph 74 of the NPPF requires local authorities to include a 5% buffer to ensure choice and competition in the market for land; or 10% where the local planning authority wishes to demonstrate a five year supply through an annual position statement or recently adopted plan, to account for any fluctuations in the market during that year; or where there has been a record of persistent under-delivery of housing, the buffer should be increased to 20%. Footnote 41 of the NPPF makes it clear that persistent under-delivery will be measured against the Housing Delivery Test (HDT).
- 3.7. It is made clear in the NPPF that these buffers are moved forward from later in the plan period and is not an additional requirement for more housing. The PPG also makes clear in paragraph 022⁵ that only one of the buffers should apply and that they are not cumulative.
- 3.8. The PPG and the HDT Rule Book detail the process for calculating HDT. This introduces a delivery test across the past three years to consider how much housing has been delivered against the housing requirement. Paragraph 12 of the HDT Rule Book also makes it clear that, for the purposes of the HDT, the housing requirement to be used is the lower of the adopted housing requirement in a Local Plan or the annual local housing need figure based on a national standardised method of calculating local housing need.
- 3.9. The most recent Housing Delivery Test was published in January 2022 and this confirmed that the Central Lincolnshire Authorities had delivered 175% of the requirement and as such a **5% buffer** should be applied to the five year requirement.
- 3.10. Given that the Central Lincolnshire authorities delivered 1,295 dwellings and a further relative release of 455 dwellings from the delivery of student and other communal accommodation making a total of 1,750 dwellings in 2021/22 it is clear that the HDT will be passed this year as the Local Housing Need figure for

2021/22 was 1,102 dwellings. Indeed based on delivery Central Lincolnshire will continue to meet the HDT and will therefore retain a 5% buffer for this year's calculation.

3.11. Therefore the five year housing requirement for Central Lincolnshire is 5,786 dwellings.

4. THE FIVE YEAR SUPPLY

4.1. Now that the requirement is known, it is necessary to assess the supply of deliverable housing sites in Central Lincolnshire.

SITES IN THE SUPPLY

- 4.2. As is detailed in the NPPF, only deliverable sites can be included in the five year period. For a site to be considered deliverable it 'should be available now, offer a suitable location for development now, and be achievable with a realistic prospect that housing will be delivered on the site within five years'.
- 4.3. Deliverable sites can come from a range of sources of information, for example through allocations in the Local Plan, or sites where full or outline permission have been granted, for example. Through monitoring it is possible to present robust, up to date information on the sites that make up the Central Lincolnshire land supply, and to understand which sites are deliverable and how many homes will be delivered in the five year period.
- 4.4. The NPPF glossary details that for sites that are not major development (i.e. fewer than 10 dwellings, or smaller than 0.5 hectares in size) and for sites where detailed planning permission has been granted, these should be considered deliverable until such time as permission expires, unless there is clear evidence that they are no longer deliverable. The glossary and the revised PPG stipulates that sites of 10 or more dwellings (or 0.5 hectares or larger) without detailed planning permission should only be considered deliverable where there is evidence that housing completions will begin on site within 5 years.
- 4.5. The Central Lincolnshire Five Year Land Supply is made up of sites that accord with the NPPF requirements including sites with permission and sites allocated in the adopted Local Plan. Officers at North Kesteven, West Lindsey and City of Lincoln have assessed each of the individual sites with regards to the expected timescales for delivery. This assessments has included an extensive consultation of land owners, developers and agents representing sites in the supply.

- 4.6. Appendix B provides a list of all sites included in the five year supply and the expected delivery rate. These are separated out according to the site status as follows:
 - Small development sites (i.e. fewer than 10 dwellings or smaller than 0.5 hectares) in Appendix B1;
 - Major development sites with detailed permission granted in Appendix B2;
 and
 - Major development sites with outline permission granted or that are allocated without permission at this time in Appendix B3.

More information is provided against sites with outline permission and sites without permission at this time where they are expected to deliver within the five year period. There are also many sites which are not included in the five year supply, due to an absence of evidence to demonstrate that they will be delivered within the five year period. Many of these sites are unconstrained and could also come forward within the five year period. Officers will continue to liaise with land owners, agents and developers to understand the latest position on sites in the supply.

- 4.7. In considering the timings and delivery rates of sites, officers have made contact with builders, agents and land owners of sites to understand their anticipated delivery, including to take account of the impacts of the Covid-19 pandemic. Typically where information obtained provides a robust position for a site's delivery, this information has been used to inform a site's trajectory.
- 4.8. In order to test the expected delivery timescales and build rates, a number of assumptions have been developed based on experience with real world example sites across Central Lincolnshire. These assumptions are set out in the accompanying Central Lincolnshire Housing Assumptions Report, October 2019.
- 4.9. In Appendix B, where a site already has planning permission, the dwelling figure is that for which permission was granted. Where a site is under construction, the outstanding dwelling figure shown is the remaining number still to be completed (at 1 April 2021) in accordance with the permission. For sites that are allocated but do not yet have planning permission the figure used is the 'indicative dwelling' set out in the adopted Central Lincolnshire Local Plan, unless through other discussions with land owners or through pre-application discussion or a live planning application it is clear that an alternative capacity is more appropriate.

SUPPLY FROM COMMUNAL ACCOMMODATION

- 4.10. The NPPF and PPG allows for account to be taken of delivery of student and other communal accommodation, based on the amount of housing they free up to the market.
- 4.11. Paragraph 34 of the Housing Supply and Delivery section of the PPG states:

"All student accommodation, whether it consists of communal halls of residence or self-contained dwellings, and whether or not it is on campus, can in principle count towards contributing to an authority's housing land supply based on:

- the amount of accommodation that new student housing releases in the wider housing market (by allowing existing properties to return to general residential use); and / or
- the extent to which it allows general market housing to remain in such use, rather than being converted for use as student accommodation.

This will need to be applied to both communal establishments and to multi bedroom self-contained student flats. Several units of purpose-built student accommodation may be needed to replace a house which may have accommodated several students.

Authorities will need to base their calculations on the average number of students living in student only accommodation, using the published census data, and take steps to avoid double-counting. The exception to this approach is studio flats designed for students, graduates or young professionals, which can be counted on a one for one basis. A studio flat is a one-room apartment with kitchen facilities and a separate bathroom that fully functions as an independent dwelling."⁶

4.12. Paragraph 35 of the same section of the PPG also goes onto make an allowance for housing for older people, where it says:

"Local planning authorities will need to count housing provided for older people, including residential institutions in Use Class C2, as part of their housing land supply. This contribution is based on the amount of accommodation released in the housing market. Further guidance is set out in Housing for Older and Disabled People."⁷

4.13. As such it is wholly appropriate to factor in development for student and other communal accommodation into the housing supply. The guidance sets out a process to identify the amount of housing released by communal accommodation using ratios for student accommodation and residential institutions. The calculations to establish these ratios have been made and are set out in Appendix A. The ratios applied to the different types of accommodation are shown below:

- 4.14. By using the Government ratios, provided in Table 3, a figure can be incorporated into the five year supply resulting from such developments.
- 4.15. There are a number of sites with permission for student accommodation or for a residential institution across Central Lincolnshire, many of which are expected to be delivered within the 5 year period (2022/23-2026/27). These developments are

expected to free up a total of 337 dwellings to the market in the five year period as is shown below.

4.16. Details of sites making up the supply of student accommodation and residential institutions is provided in Appendix B4.

WINDFALL ALLOWANCE

- 4.17. The NPPF¹⁰ states that 'where an allowance is to be made for windfall sites as part of anticipated supply, there should be compelling evidence that they will provide a reliable source of supply. Any allowance should be realistic having regard to the strategic housing land availability assessment, historic windfall delivery rates and expected future trends'. The adopted Local Plan allocates sites of 25 dwellings or more, therefore there is justification for including a windfall allowance for small sites below 25 dwellings. The inclusion of these sources of windfall were endorsed by the Local Plan Inspectors.
- 4.18. With the policies in the adopted Local Plan providing a positive and flexible approach to development in settlements across the area, small windfall sites continue to make up an important part of the supply in Central Lincolnshire. In previous five year land supply reports windfall has been included from two sources:
 - An allowance of 75 dwellings per year from sites of up to 25 dwellings in the City of Lincoln. This was based on historical data of delivery on such small sites in the City of Lincoln area which was a very conservative estimate given that the average delivery on these sites between 2006/7 and 2020/21 was 120 dwellings per year.
 - An allowance based on the remaining growth levels in small and medium villages under Policies LP2 and LP4 of the adopted plan, averaged out across the remainder of the plan period (excluding the first two years to allow for sites with permission and to avoiding double counting in these years).¹¹
- 4.19. This was a very conservative allowance with small sites of up to 25 dwellings delivering a significantly higher amount of development in each year since the Local Plan was adopted in 2017. This is shown in the table below:

- 4.20. The Local Plan is currently being reviewed and as at October 2022, it is at the examination stage. The new Local Plan now seeks to allocate sites of 10 or more dwellings, reduced from the 25 dwelling threshold in the 2017 Local Plan. Furthermore the new Local Plan now removes the percentage growth approach of policies LP2 and LP4 in the adopted Local Plan and it is replaced with a flexible and positive policy which allows for windfall development to take place in named settlements.
- 4.21. The revised policies and threshold for site allocations in the new Local Plan are expected to continue to deliver a high number of dwellings through windfall sites in the area, but clearly the exact effects of the new policy framework are somewhat uncertain.
- 4.22. As such it is proposed to take a conservative position and keep the evidence which would justify any windfall allowance under review when the new plan is adopted. Firstly, if we look at a reduced site size threshold for what is considered to be a small site consistent with the allocation threshold and delivery over recent years it is clear that sites of fewer than 10 dwellings still make up an important part of the supply:

- 4.23. Looking at this delivery it is clear that more than 200 dwellings will be delivered on small sites of up to 10 dwellings annually. However, taking a conservative approach, it is proposed that this figure is reduced to 150 dwellings per year this is more than a 35% reduction on the fewest homes delivered in any given year on sites of fewer than 10 dwellings in the past 5 years, and more than a 50% reduction against the three most recent years. It is also proposed that this is only applied in years 4-5 of the five year period to avoid double counting of small sites with permission which are also included in the supply.
- 4.24. Therefore, it is proposed that **300 dwellings are included in the five year period** from windfall sites, spread evenly between years 4 and 5.

5. CALCULATING THE FIVE YEAR SUPPLY

5.1. The following table provides a summary of the five year supply of deliverable housing sites based on site status at 31 March 2022. Full details are set out in Appendix B.

The results show that the Central Lincolnshire Authorities have sufficient land to more than meet the five year requirement of 5,786 dwellings and can demonstrate 8.05 years of deliverable supply.

5.3. The Central Lincolnshire Districts will continue to work with developers to ensure a consistent and sustainable supply of housing land. Through the review of the Central Lincolnshire Local Plan, additional sites may be allocated and added to the supply where evidence justifies their inclusion in subsequent reports.

Table 13 demonstrates the ratio for each of the Central Lincolnshire authorities and also what the ratio would be for Central Lincolnshire as a whole. Given the differences between each of the districts (in terms of their built nature and the types of student accommodation likely to be delivered) it is proposed that, rather than taking the Central Lincolnshire average of 2.78, that the ratio for each District be applied where student accommodation is proposed.
