Statement of the Representations Procedure and Arrangements for Inspection of the Central Lincolnshire Local Plan (Proposed Submission 'Publication Draft' Version)

Notice is hereby given, in accordance with regulations 19 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that the Central Lincolnshire Joint Strategic Planning Committee is publishing the Central Lincolnshire Local Plan for public consultation. This notice gives details of the arrangements for inspection and public involvement.

Title of the document:	Central Lincolnshire Local Plan
Subject matter and area covered:	The Local Plan identifies land and allocates sites for different types of development, such as housing and employment, to deliver the planned growth for Central Lincolnshire to 2040. It also covers a wide range of other planning related matters, in the form of policies, for use, primarily, in the determination of planning applications. It also allocates certain areas for protection. It covers the whole of the City of Lincoln, North Kesteven and West Lindsey (Central Lincolnshire) authority areas.
