# 1. Introduction

- 1.1 The Central Lincolnshire Local Plan team is reviewing the adopted Local Plan. The plan covers the three local authority areas of City of Lincoln, North Kesteven and West Lindsey and addresses strategic planning issues including the settlement hierarchy. Once reviewed and adopted, the plan will be used in determining future planning applications, alongside adopted Neighbourhood Plans.
- 1.2 The National Planning Policy Framework (NPPF) and National Planning Practice Guidance (PPG) state that the purpose of the planning system is to contribute to the achievement of sustainable development. They require the planning system to actively manage patterns of growth in support of sustainable transport objectives, where services and facilities can be accessed other than by the private car and to support a prosperous rural economy with the flexibility to appropriately meet its needs.
- 1.3 The current 2017 Local Plan contained a settlement hierarchy in Policy LP2 which sought to support the spatial strategy by focussing development at locations with good levels of services and facilities while allowing smaller settlements to grow proportionately and appropriately.
- 1.4 This Services and Facilities Study forms part of the evidence base for the emerging Central Lincolnshire Local Plan review. The purpose of the study is to collate up to date information on the services and facilities for all settlements within Central Lincolnshire. It will help to provide an understanding of how well each settlement serves its local population, whilst giving an indication of each settlement's potential to facilitate the needs of any future development. This study will be used to help inform the distribution of development when considering potential site allocations in the next version of the Local Plan review. It will also help to identify where providing new development could enhance the sustainability of settlements. It may also be used by the Authorities to support the determination of planning applications.
- 1.5 The Study aims to identify all settlements within Central Lincolnshire and to identify and quantify those key services and facilities within each of them. It should be noted that the data contained within this study was collected over 2018 to 2019 and may be subject to change.

# 2 Methodology

- 2.1 A comprehensive list has been produced of all settlements within Central Lincolnshire. This includes settlements named in the adopted Central Lincolnshire Local Plan 2017, other studies, supporting documents and previously adopted Local Plans and suggestions and corrections added by District Councils, Parish Councils and the public.
- 2.2 A list was then produced of all services and facilities for which information could be obtained and quantified in order to assess the overall sustainability of a settlement. Each service and facility and data source is listed below and suggested means of quantifying them where appropriate. Where there are no facilities within a settlement, the section/s have been left blank.

# a) Primary School

2.3 A list of all primary schools was obtained from the Lincolnshire County Council web site in spring 2019 and the number of primary schools in each settlement recorded. The location of a primary school within a settlement does not guarantee that pupils from that settlement will attend the school or that they will travel to school by means other than the private car, but the presence of a school within a settlement increases the potential. At this stage no assessment of a school's capacity or physical potential to increase capacity has been made.

# b) Secondary School

2.4 A list of all secondary schools was obtained from the Lincolnshire County Council web site in spring 2019. A head count for each of the schools as of 2018 and capacity at county wide special/ referral schools was also recorded. This helps to distinguish between larger mainstream secondary schools and smaller schools and specialist facilities which have much smaller student numbers/ capacity. At this stage no assessment of a school's physical potential to increase capacity has been made.

## c) Post Office

2.5

Post Office details were obtained from the Post Office web site, branch finder and officer knowledge.

- A indicates settlements with several Post Offices or where there is a Post Office which is open most days of the week and for full days;
- B indicates settlements which have a Post Office, but it is only open for one day or a few days a week and at limited times;
- C (m) indicates a limited, mobile service.

## d) Convenience Store

- 2.6 This information has been obtained from the non-domestic rates data from North Kesteven District Council and West Lindsey District Council, store finder facilities on web sites for stores such as co-op, Spar, Premier, etc, general map-based web search and officer knowledge.
  - A indicates settlements with more than one convenience store;
  - B indicates settlements with at least one convenience store.

### e) Pharmacy & other healthcare

- 2.7 This information has been obtained from non-domestic rates data from North Kesteven District Council and West Lindsey District Council and a general web site search cross referenced with NHS/ Lloyd's/ co-op/ Boot's and other pharmacy web site location searches and officer knowledge. Other health care facilities include chiropractors, osteopaths, sports injury clinics, etc.
  - A indicates settlements with more than one pharmacy/ dispensary/ other health care facility;
  - B indicates settlements with at least one pharmacy/ dispensaries/ other health care facility, including B(m) for a mobile facility.

## f) Doctors Surgery

- 2.8 This information has been obtained from non-domestic rates data from North Kesteven District Council and West Lindsey District Council and a general web site search and officer knowledge.
  - A indicates settlements with more than one doctors surgery;
  - B indicates settlements with at least one doctors surgery.

## g) Dentist

- 2.9 This information has been obtained from non-domestic rates data from North Kesteven District Council and West Lindsey District Council and a general web site search and officer knowledge.
  - A indicates settlements with more than one dentist practice;
  - B indicates settlements with at least one dentist practice.

## h) Library/ Mobile Library

- 2.10 Libraries are not just places where books can be borrowed, but also act as a focus for community information and activity and can allow internet access for those without a personal computer. The location of libraries, their opening times and village stops for mobile libraries have been obtained from the Lincolnshire County Council web site.
  - A indicates settlements with libraries that are open for more than four full days in a week or equivalent (two half days = one full day);
  - B indicates those libraries that are open for four full days (or equivalent) or less in a week.
  - M Mobile library timetables show a stop period, usually half an hour, but occasionally longer, on set days, generally once a month. Mobile library stops are recorded separately with a single tick for each village visited.

### i) Place of Worship

- 2.11 Places of worship can also act as a focus for community information and activity, although this information is much harder to gather. The location of places of worship has been obtained from a general web site search and officer knowledge. But there has been no assessment of opening times or services/ activities provided.
  - A indicates the presence of one or more places of worship

### j) Village/ Church Hall/ Community Centre

2.12 Village halls, church halls and community centres can act as a focus for community information and a range of activities, although information on the range of activities is harder to gather. The location of village halls, church halls and community centres has been obtained from a general web site search and officer knowledge.

A - indicates the presence of a village hall, a church hall and/ or a community centre

### k) Bus Service/ Frequency

- 2.13 Information on bus services, service frequency and those areas served by 'CallConnect', has been provided by Lincolnshire County Council. Where a settlement is served by several services, these have been averaged out across the whole area for all services. Where the service generally runs every 15 minutes, 30 minutes, hourly or 2 hourly throughout the day, this has been recorded. Where the service varies throughout the day, with some gaps of more than 2 hours, or where the first and last bus do not allow for 'commuting', this has been recorded as an 'infrequent' service. Almost all of Central Lincolnshire is covered by the CallConnect service, a public bus service that operates in response to pre-booked requests. The fully accessible minibuses operate from 7am to 7pm Monday to Friday and 7:30am to 6:30pm on Saturday and collects from designated locations in a settlement or home address where appropriate to a location within it's operating area or provides a connection to other bus and train services to destinations further afield. Where CallConnect is the only service available for a settlement, this is recorded. Services and frequency are recorded as:
  - 15 mins, 30 mins or hourly;

- 2 hourly;
- Infrequent (and where also served by CallConnect);
- CallConnect only or
- Blank = No service is available

### I) Railway Station

2.14 The location of existing railway stations has been recorded against the appropriate settlement as a fixed facility. At this stage no assessment of current or potential services has been made.

## m) Employment

- 2.15 Information on businesses/ potential employment opportunities for each settlement has been obtained from the 2019 non-domestic rates data from North Kesteven District Council and West Lindsey District Council. Some non-domestic uses attributed to a settlement have not been counted as a potential source of local employment, such as:
  - photovoltaic installations;
  - sewage treatment works;
  - adverts;
  - individual self-catering holiday units;
  - communication stations; and
  - atm machines.

Although they may offer some employment in the form of monitoring/ maintenance/ etc, this is likely to be of a very limited nature and to be provided by/ for a much wider area and therefore not just providing potential employment opportunities for the settlement where it is located or contributing to its sustainability.

- 2.16 Isolated businesses that are greater than 1km away from the nearest settlement have been recorded as 'isolated' because although they may provide employment, they cannot be attributed to any one settlement and cannot be said to contribute to the sustainability of any particular settlement.
- 2.17 The number of full-time employees (or equivalent) for each business is not known or easily obtained and therefore an estimate of the employment potential of each business has been based on its nature, size and officer knowledge. An attempt has also been made to reflect the nature of employment across the Central Lincolnshire area.
- 2.18 For an indication of the employment potential of schools, the size of the school, based roughly on pupil numbers and current school capacity has been obtained from school web sites, Ofsted web site and inspection reports and Lincolnshire County Council. This is considered to give an indication of likely teacher and support staff numbers. All remaining types of potential employment opportunities within a settlement have been placed into the three following categories:
  - Small Small scale non-domestic uses such as boarding houses, small garages, clubs, village halls, small shops and workshops, etc are considered to offer 'small scale' local employment potential for a limited number of people, such as mechanics, managers, a shop keeper, caretakers, cleaners, etc.
  - Medium Small village primary schools (less than 100 pupils), larger workshops, offices, cafes, public houses, larger shops, doctors and dentists limited to one or two practitioners, etc are considered 'medium' employers.

- Large Larger schools (with 100 or more pupils), factories, larger offices and shops (such as larger co-op's and garden centres), larger surgeries (with more than 20 staff members), etc are considered 'large' employers.
- 2.19 Each settlement has then been assigned a score, based on the presence of known businesses and the potential employment opportunities present at this time, as follows:
  - A+ indicates those settlements with more than five 'large' employers or more than 25 'small' to 'medium' employers, based on the nature, size and local knowledge of the businesses.
  - A indicates those settlements that are considered to contain between two and five 'large' employers, or between ten and 25 'small' to 'medium' employers, based on the nature, size and local knowledge of the businesses.
  - B indicated those settlements that contain one 'large' employer or five to nine 'small' to 'medium' employers, based on the nature, size and local knowledge of the business.
  - C indicates those settlements with at least one and up to four 'small' to 'medium' employers, based on the nature, size and local knowledge of the businesses.
    - All other settlements that do not meet the above criteria have been left blank.

# 3 Conclusion

-

- 3.1 The report and study provide information on the services and facilities for the settlements within Central Lincolnshire and describes how that information is gathered and assessed. It is intended to help provide an understanding of how well each settlement serves its local population and an indication of it's potential to meet the needs of any future development.
- 3.2 In collating and verifying the data, the parishes and communities across Central Lincolnshire have been consulted on the data collected and assumptions made. Feedback from the parishes and other stakeholders has been evaluated and changes incorporated where necessary to ensure that the data is robust and effective.
- 3.3 The study will be used to help identify the role and function of individual settlements, inform the distribution of development when considering potential site allocations and will help to identify where the sustainability of a settlement could be enhanced by providing new development. It will be periodically reviewed as necessary to ensure that it remains up to date and robust and may be used to support the determination of planning applications.
