## Privacy Notice – Educational Art Competition

# **Our Commitment to Your Privacy**

As part of our commitment to protecting your information, we have updated our Privacy Notice to explain how we collect, store and handle your personal data.

We have always been careful to protect your information, but this is part of our ongoing commitment to be transparent about how we use your information and keep it safe. This will also give you more clarity over how your information is being managed.

Through our privacy notice, we have addressed the new standards introduced by the UK General Data Protection Regulation (GDPR), and the Data Protection Act 2018.

#### Who we are

North Kesteven District Council is registered with the Information Commissioner's Office (ICO) as a 'data controller' under Z5680267. This means we will process and hold your information for the purpose of this educational art competition. Entries are invited from children aged 11 to 16 years of age. The relevant consent form must be completed and submitted alongside the artwork.

### What information do we collect

The personal information we collect are:

- Your child's name
- Your child's age
- Your child's artwork, a brief description of their entry and how their entry reflects them as an individual
- Your name
- Your postal address
- Your telephone number
- Your email address
- Your signature.

As the personal information collected is provided directly by you, under the GDPR, the lawful bases we rely on for processing your personal information are:

 GDPR Article 6 (a) – You gave us your consent. However, you are able to remove your consent at any time. You can do this by contacting dataprotection@n-kesteven.gov.uk

When we rely on your consent to process your personal information, you have the right to withdraw your consent at any time by notifying us, but withdrawing consent may not affect the material that has already been used and we will do our best to stop others doing so, however we cannot guarantee this. In addition, please note

that once published on the internet and social media, we do not have control of the storage or use of the images. We will not have control of the storage or use of images taken by the local press and media or other attendees at a showcased event.

# Why we collect your data

We collect your contact details for the purpose of administering the competition.

We collect your child's name, age, artwork, brief description of their entry and how it reflects them as individual in order to maintain accurate records of the artworks submitted and attribute them to your child whilst on display. A range of shortlisted entries will be showcased in a collated space at The Hub/National Centre for Craft and Design, Sleaford, where visitors will be able to nominate their favourite(s). This information may also be publicised via Facebook where people can vote/nominate their favourite(s). As far as is reasonable and practicable, we will ensure that the information recorded is accurate and kept up to date.

## How we collect your data

We are collecting your data via the use of a downloadable/printable consent form, alongside your child's artwork, which can be:

Entries can be brought to the Council Offices at Kesteven Street and the Hub (North Kesteven District Council Reception is open 9am 5pm, Monday through to Wednesday, closed between 1pm 2pm for lunch, and the Hub is open 10am 5pm, Monday through to Saturday, and 10am 4pm Sunday and Bank Holidays.

# When we'll share your data

We will share your contacts details within the Communications Team for the purposes of administering the competition.

We will share your child's name, age, brief description of their entry and how it reflects them as an individual to those who are shortlisting the competition. A range of shortlisted entries will be showcased in a collated space at The Hub/National Centre for Craft and Design, Sleaford, where visitors will be able to nominate their favourite(s). This information may also be publicised via Facebook where people can vote/nominate their favourite(s). We will only share relevant information about you with third parties when there is a legal basis for us to do so.

We do not sell your personal information to anyone outside of North Kesteven District Council and will not share your information for marketing purposes.
