

Terms and Conditions – Central Lincolnshire Design Code Survey Gift Card Prize Draw 2025

1. Entrants into the prize draw shall be deemed to have accepted these Terms and Conditions and to comply fully with them
2. Entries into the Central Lincolnshire Design Code Survey Gift Card prize draw 2025 can only be made by those completing the survey as an individual, and not by those completing the survey on behalf of a business, charity, Town or Parish Council, or other organisation
3. Entry to the prize draw is restricted to one entry per person
4. The individual winners must be residents of Central Lincolnshire (City of Lincoln, North Kesteven or West Lindsey) or have been at the time the survey was issued
5. Employees and Councillors of City of Lincoln Council, North Kesteven District Council or West Lindsey District Council are ineligible to enter, although contributions to the survey are still welcome
6. All entrants to the gift card prize draw must be aged 16 years or older
7. The gift card prize draw is open to individuals who answer the mandatory questions in the survey. You do not have to complete the optional equality monitoring questions at the end of the survey to enter into the prize draw
8. Your chances of winning the gift card prize draw do not depend on any of the answers given in this survey
9. The gift card prize draw will run from 00:01 26th February 2025 to 23:59 9th April 2025. To be entered into the prize draw surveys must be submitted by the closing date and entries received after this date will not be eligible for entry into the prize draw
10. This draw is being run on behalf of Central Lincolnshire by North Kesteven District Council ('The Council'). The Council accepts no liability or responsibility for entries that are incomplete for any technical or other reason, or that are lost, mislaid, damaged, delayed or undelivered, regardless of cause
11. The Council will not accept proof of transmission as proof of receipt to the gift card prize draw
12. Proof of posting is not proof of receipt and no responsibility will be taken for late, damaged or lost survey and corresponding gift card prize draw entries
13. The prizes consist of three £50 [Lincolnshire gift cards](#)
14. The three winners will be selected at random from all valid entries no later than 28 days after the closing date. The draw will be independent and viewed by the Corporate Information Manager at the Council
15. Winners will be contacted via email address or telephone within 28 days after the closing date
16. Prizes can only be given if the correct contact details have been made available
17. The Council reserves the right to request the winners provide proof of identity, age and residence
18. The Council's decision is final and no correspondence will be entered into
19. The prize is non-exchangeable, non-transferable and is not redeemable for cash or any other prize
20. The Council accepts no responsibility for any damage, loss, liabilities, injury or

disappointment incurred as a result of entering into the gift card prize draw or accepting the prize

21. The Council will not publish the name of the winners without their consent
22. Unsuccessful entrants will not be contacted
23. If a winner's entry is invalid, or in breach of these Terms and Conditions, this will be forfeited and the Council shall be entitled to select another winner
24. The Council reserves the right to cancel the gift card prize draw or alter any of the rules at any stage, if deemed necessary, for example, if circumstances arise outside of our control
25. If a winner is unable to be reached, after we have made reasonable attempts to contact them, we reserve the right to either offer the prize to another entrant, or to re-offer the prize in any future prize draw
26. North Kesteven District Council is compliant with the UK General Data Protection Regulation and the Data Protection Act 2018 and will be governed subject to any applicable data protection law requirements
27. All personal data received as part of the prize draw will be securely held and used by the Council in accordance with all relevant data protection laws
